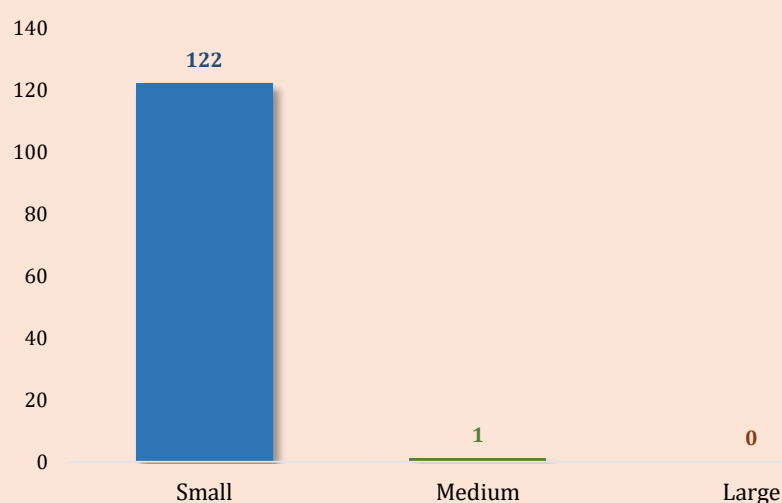

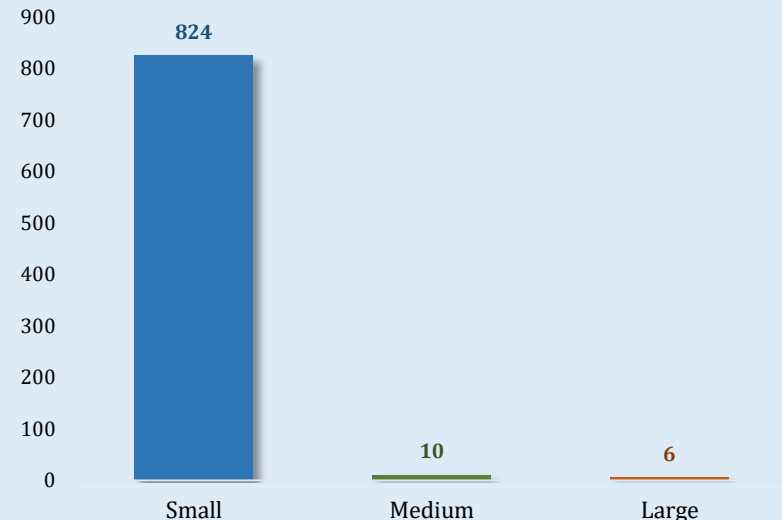

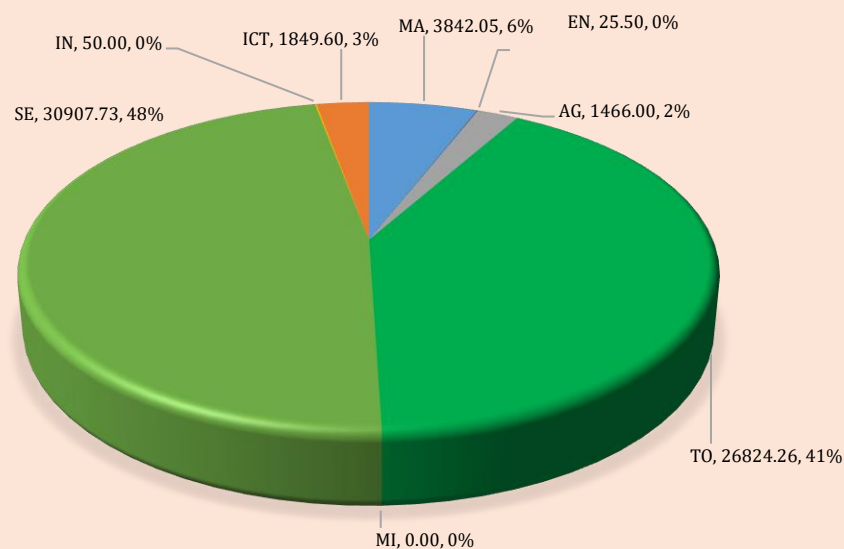
Proposed FDI Industries on Ashadh * (Scalewise)



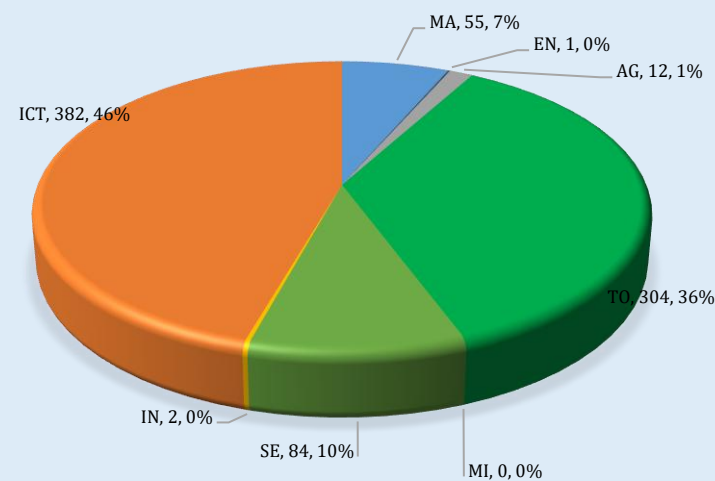
Proposed FDI Industries Till Ashadh * FY 081/82 (Scalewise)

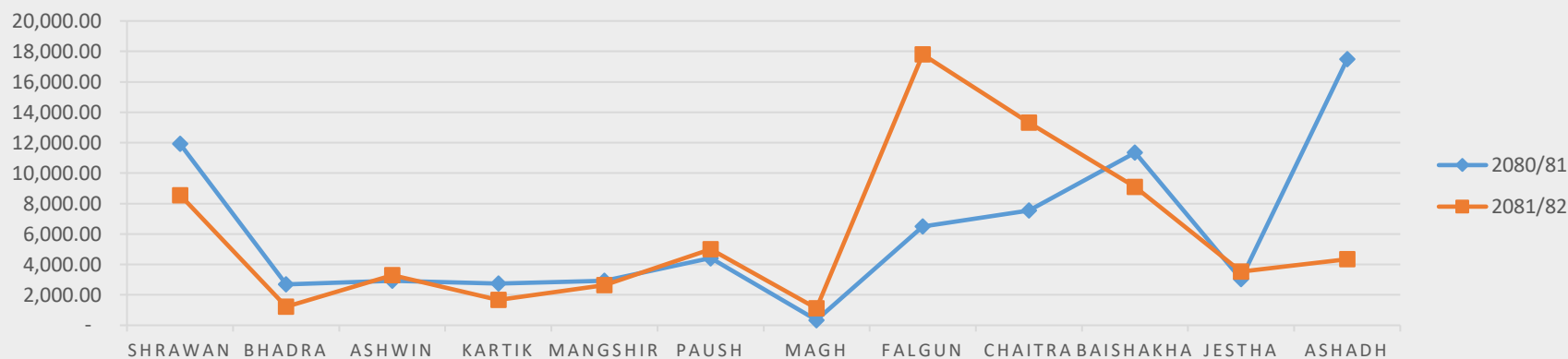
