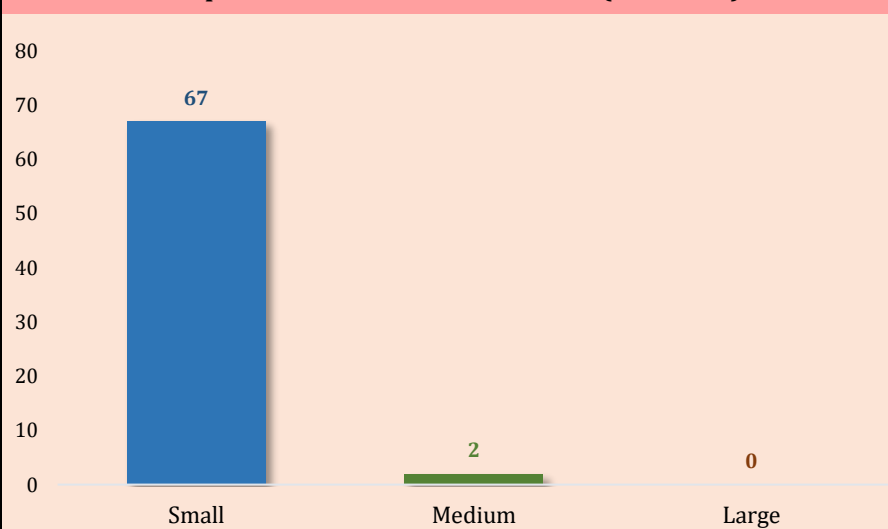

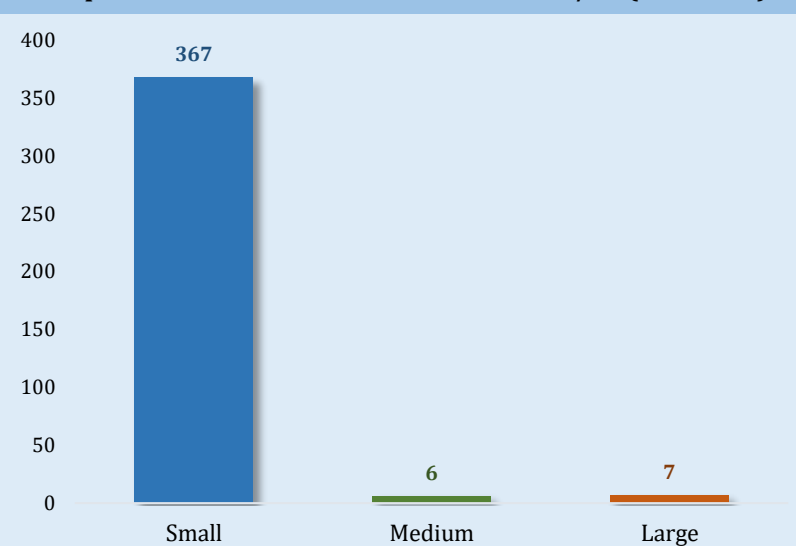

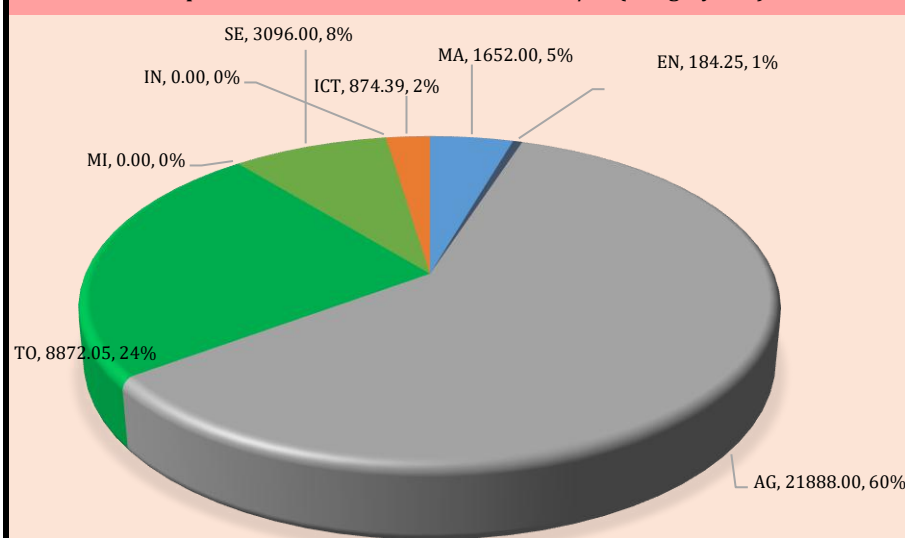
Proposed FDI Industries on Kartik* (Scalewise)



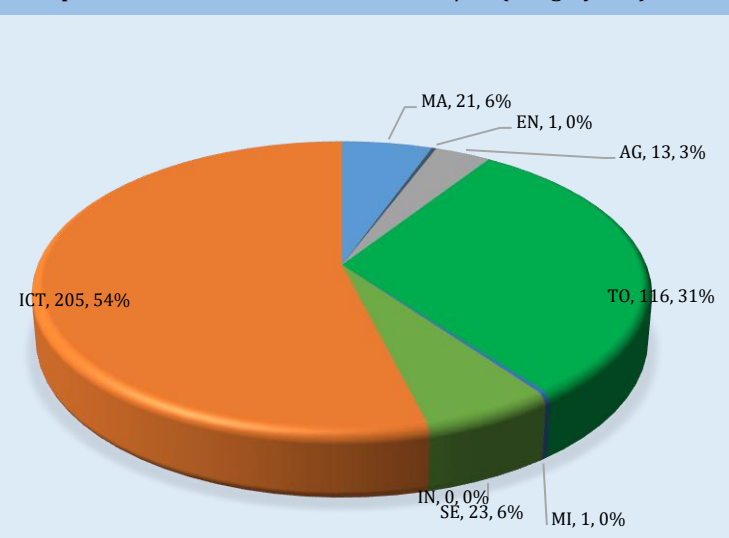
Proposed FDI Industries Till Kartik* FY 082/83 (Scalewise)

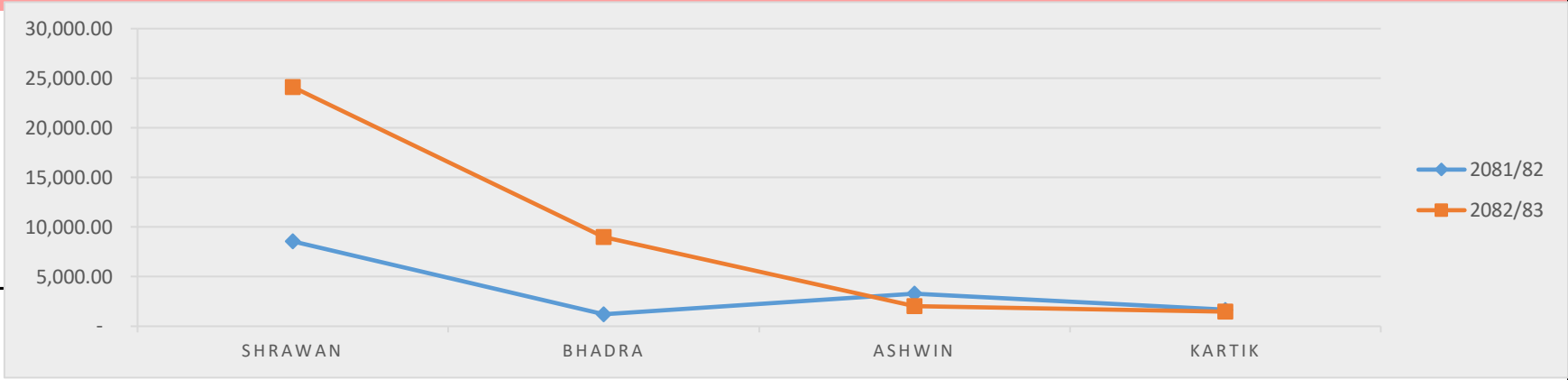
